I know there are a lot of people that would like to get nicer coats this year, but this will require an additional \$10k (+/-) from our funds the first year, which will either have to come from added money, additional sponsorship or cut-backs in awards. So, please let your board members know how you feel about this as soon as possible. I hope if any of you have ideas of ways we can save money or raise additional funds you will discuss them with your representative and being willing to help

implement those ideas.

Remember, early July is the cut-off date for getting ads in the program for the finals, so please get out and get sponsorships for your event sold for the finals in the coming months so we can get our supporters as much publicity as possible. Please try to get as many sponsors as possible as it all goes back to the contestants and the more sponsorship we have the more added money, nicer coats and awards we will have at the finals.

Additionally, please do not forget to pay your finals futurity prior to June 1, as it will go up to \$100 per event after June 1. It is required for everyone competing at the finals in leau of the mandatory \$50 sponsorship per event required in previous years. Have a safe, prosperous, wonderful summer and I hope to see you at the finals in August.

To work an MRCA first approved or MRCA straight approved rodeo, all rodeo personnel must have a current MRCA Personnel card. Any stock Contractor using personnel not having a current card will be fined the cost of the personnel card for each person working the rodeo in an official position and the card will be issued for the personnel in question. Personnel must work 3 MRCA 1st sanctioned or 5 co-approved rodeos to work finals.

MEMBERSHIP & DUES: **Delete Rule** : Pg 4 Rule 1E **Replace with:** A complimentary "C" card will be issued to approved contractors.

OFFICIAL RODEO RULES: *amend* Page 20, rule 10: All rodeos must use two timers and two watches **or one watch and one electronic timer system** in all events. A. The primary official watch **or electronic timer system** shall be graduated in 1/10 of a second...

CONDUCT OF RODEO: There must be 2 qualified bullfighters at each sanctioned rodeo.

COWGIRL'S BARREL RACING RULES **Delete Rule**: pg 48 Rule 2.

AWARDS: The Board of Directors may opt to purchase finals coats once every 5 years. ie. The first year purchase a very nice coat and consecutive years purchase patches indicating the year of qualification to the finals. Persons qualifying to their first finals will receive a coat and then receive patches after that. All money left in the coat fund at the completion of the year will be left in the coat fund.

Futurity Fees are as of the date received by the MRCA Office per membership dues deadlines. (May be paid separate from membership.) \$25 if paid by December 31, \$50 if paid Jan 1-May 31, \$100 if paid June 1-prior to competing at finals
